The following are the Minutes of the meeting of the West Cornwall Township Municipal Authority held at the West Cornwall Township building situate at 73 South Zinn's Mill Road, Quentin, Lebanon County, Pennsylvania on Tuesday, January 3, 2017 at 7:00 p.m. The meeting was duly advertised as required by applicable statutes of the Commonwealth of Pennsylvania.

It was announced that the Supervisors appointed William Matthews to another five year term on the Municipal Authority. The Township Supervisors did not reappoint Frank Dombrowski because he is moving out of the Township. The Board of Supervisors will appoint a person to replace Mr. Dombrowski on the Authority Board at a later date.

The Minutes of the previous meeting were unanimously approved.

The Solicitor conducted the reorganization meeting for the election of officers. Upon Motion Duly made, seconded, and unanimously carried, the following officers were elected to hold office for 2017:

ENGINEER'S REPORT:

Mr. Steckbeck was unable to attend the meeting because of another commitment, and there was no Engineer report given.

SOLICITOR'S REPORT:

The Solicitor reported that everything is ready to go to closing concerning the financing with West Cornwall Township. The Solicitor indicated that the documents will be ready for signature and closing within the next two weeks.

MANAGER'S REPORT:

Steve Ogurcak reported that there were no maintenance issues since the last meeting.

There were no delinquents for Stoberdale, and Mr. Ogurcak had not yet received the delinquent reports from the City of Lebanon Authority.

There were no conduit payments due or made.

FINANCIALS:

Mr. Ogurcak reported that the amount in reserves are \$197,255.71.

Scenic Ridge Development continues to be active. There is no expected activity on the Eagle Rental project.

- Mr. Ogurcak reported that he would be sending the balance of the money that is in escrow back to Eagle Rentals. All costs to date have been paid.
 - Mr. Ogurcak reported the financials for 2016. The report has unanimously approved.
- Mr. Ogurcak reported that the approved Budget for 2017 does reflect a slight increase in the sewer rates for Quentin. There was no increase for the Stoberdale billing for 2017.
- Mr. Ogurcak reported on the dates and times for the Authority meetings for 2017. The dates and time were unanimously approved by the Authority, and the Manager was directed to coordinate the advertisement of the Ordinance with the Secretary for the Township.
