### MINUTES OF MEETING WEST CORNWALL TOWNSHIP MUNICIPAL AUTHORITY

The following are the minutes of the meeting of West Cornwall Township Municipal Authority held in the West Cornwall Township building situate at 73 South Zinn's Mill Road, Quentin, Lebanon County, Pennsylvania, on Tuesday, August 6, 2019 at 6:00 p.m. The meeting was duly advertised as required by the applicable statutes of the Commonwealth of Pennsylvania.

Minutes of the previous meeting were unanimously approved.

Manager's / Engineer's Report – Jeffrey Steckbeck presented the audit and directed that the statement be attached to the minutes of the meeting. He next reviewed the Quentin and Stoberdale checking accounts and money market accounts and directed that those statements be attached to the minutes.

Mr. Steckbeck next reviewed the Cassidy Court sinkhole and the discussions that have been ongoing with the Township over payment for the sinkhole repairs. Mr. Steckbeck presented a bill for repairs in the amount of \$508.00 to be reviewed by the Authority together with the Township's request that the Authority pay the same. Mr. Foltz made a Motion to approve payment of the bill, which Motion was seconded by Mr. Matthews. Upon vote, the Motion was defeated.

Mr. Steckbeck next reviewed the Public Works Department operation and management budget.

Mr. Steckbeck next reviewed the West Cornwall Township Municipal Authority evaluation of commercial customer sewer flows and historical EDU usage. The Manager pointed out the significant overage of usage based on allotted EDUs by a number of customers. Nevertheless, it was suggested that due diligence investigation be made to find out whether some customers' water usage translated to usage of sewer capacity. Mr. Foltz made a motion to hold off on issuing letters to customers that are significantly over in usage until more information can be secured by the Manager / Engineer. The motion was approved with all in favor.

Next the Engineer raised the issue of the purchase of the Quentin Water Company. After discussions, it was decided that no further action on the same would be taken until further due diligence investigation into the propriety of the same could be made by the Engineer and Solicitor.

**Solicitor's Report** – Marc Hess reported on five deliquent sewer accounts as follows:

- 50 North Zinn's Mill Road A motion was made to proceed with a Writ of Scire Fascias as to this property and was approved with all in favor.
- 34 Alden Lane upon which the Authority has a judgment. A Motion was made to notify any mortgage holder of the Authority's intention to execute on its lien and list the property for sheriff's sale. The motion passed with all in favor.
- 42 South Zinn's Mill Road Is currently delinquent in the amount of \$585.08 and
  has been delinquent for approximately one year. A motion was made for the
  Solicitor to send the property owner a 10-day notice of repayment or proposal for
  repayment. If payment or a proposal for repayment is not received within 10
  days from the date of the letter, the Solicitor shall proceed with filing a lien.
- Quentin Riding Club 29 East Main Street, Units A and B The Authority determined that it would wait for distribution of sale proceeds to be paid for this lien.

• 456 Old Mine Road – Currently owes \$1,237.65. A motion was made to proceed with filing a lien against the property and passed with all in favor.

There being no further business to come before the meeting, the meeting as duly adjourned at 6:42 p.m.
